CITY OF PLATTE CITY COUNCIL PROCEEDINGS APPROVED REGULAR MEETING January 21, 2014

Mayor Gustad called the meeting to order at Platte City Hall at 7:30 p.m. Those present for roll call were: Mitch Antonsen, Rick Gustad, Rich Hoppe, Jarrod Lang, and Jerry Overweg. Councilmembers Joel Foxley and Todd Spoelstra were absent. Others present were: Shauna Meyerink, Ralph Nachtigal, and Brandon Semmler.

AGENDA.

MINUTES. Councilmember Hoppe moved and Antonsen seconded to approve the January 6th regular meeting minutes as presented. Motion carried on voice vote of 4-0.

REPORTS.

Mayor and Council: No reports.

Finance Officer. Finance Officer Meyerink reported on the following topics: 1) Presented the thank you letter from the Avera Health Center for the endowment contribution. 2) Presented the December 2013 financial report.

Police Department. Chief Semmler had no report. Mayor Gustad questioned how David's training was going thus far. Semmler replied that it was going good.

Public Works. No report.

PUBLIC FORUM.

BUILDING PERMITS.

CLAIMS.

Councilmember Lang motioned to approve all claims as presented. Motion seconded by Councilmember Hoppe. Motion carried on roll call vote of 4-0. (Attached as separate document)

OLD BUSINESS.

NEW BUSINESS.

Noteboom – Diagonal Parking Request: Councilmember Lang explained the move to Wilmer's is fast approaching and as the parking situation was evaluated, it was deemed that switching the parking to diagonal instead of parallel would be better. Councilmember Hoppe stated he was concerned about the truck flow by Severson Station. Overweg questioned why the customers could not use the south side of the street as well. Mayor Gustad questioned if it would be a benefit or if the number of parking spaces would really change since the setback from the corner and the alley would need to be calculated as well. Lang explained that on a busy day the number of vehicles can range to upwards of fifteen at one time. The exact number of spaces was not calculated. Councilmember Antonsen stated he would like to see the proposal on a drawing. Councilmember Lang stated that he was trying to find a solution to the conjestion of traffic and the flow of traffic come the time for the move. Councilmember Lang motioned to table the request until additional information can be provided. Motion seconded by Councilmember Overweg. Motion carried on a voice vote of 4-0.

Set Public Hearing – Temporary Liquor License: Councilmember Lang moved and Antonsen seconded to set the public hearing for the temporary liquor license request from the Yellow Rose for the Cattlemens Banquet on February 22nd. Motion carried on voice vote of 4-0.

STOP Grant Request: Mayor Gustad explained he received a call from States Attorney Tom Deadrick to request the commitment of \$1,000.00 for the STOP Grant again. Councilmember Hoppe moved and Lang seconded to commit a \$1,000.00 to the STOP Grand program for 2014. Motion carried on a voice vote of 4-0.

Lot 47 of Riverside Acres: Mayor Gustad informed the council that the purchase agreement may or may not be signed by Guymon's as they have a business opportunity they are trying to figure out. Guymon's informed Finance Officer Meyerink of the situation and told her they would have a definite answer by Spring. Council asked Meyerink to send a friendly letter asking Guymon's to make a decision by March 15th. Meyerink will provide updates as they come.

Resolution No. 012114-01 (Cal Pipal Property Purchase): Meyerink presented Resolution No. 012114-01. Councilmember Antonsen moved and Hoppe seconded to approve Resolution No. 012114-01, recognizing the need to acquire property and authorize Mayor Gustad and Finance Officer Meyerink the power to sign necessary paperwork to do so. Motion carried on a voice vote of 4-0.

Section 1
